Choices in Mission for September!

For September Choices In Mission is Neighbors Helping Neighbors—Laundry Night! One night of laundry can benefit over 75 individuals - that's a lot of laundry. The cost for 4 hours of laundry for that many people is about \$350. Money donated to Choices In Mission projects is matched up to \$2500.

This summer the Newton United Way reported that 37% of Newton residents do not make enough money to meet their basic needs. Paying for laundry is one of those needs. When you are looking for a job, are a child in school, or shopping for food, clean clothes are a necessity.

When the end of the month comes, and money has run out, this program helps those who must choose between paying for food, electricity or washing the clothes. A standard load costs \$2.75 to wash. The dryer costs 25 cents for 6 minutes. Neighbors Helping Neighbors also provides laundry soap.

Laundry Night Volunteers Needed

In conjunction with the Choices in Mission, First Lutheran is providing the volunteers for laundry nights in September. A laundry night volunteer greets the guests at laundry night, and puts the quarters into the machines. Laundry nights in September will be the 10th and 24th. Neighbors Helping Neighbors is there from 4-8pm. Any amount of time you can be there is appreciated. One or two hours is typical for volunteering. Zinga News!

Another summer is coming to an end, and the last teams are leaving the Children's Hospital, Zinga. At the end of the month, Paula and Denny Lofstrom will be returning to the States to spread the word about the work at the hospital and raise funds for the continued construction there. We at First Lutheran welcome them to join us on Sunday, October 14.

One necessary piece of equipment was acquired this summer: the hospital now has an ambulance. It went out on its first run the very day it was delivered!

Earlier this summer, IHP-TZ put in a bid for a reconditioned bus, but with just \$18,000 available for that, the bid fell short. The earmarked funds are in the bank, but more is needed. A suitable reconditioned bus will cost an estimated \$33,000. So far this year, close to \$1,000 has been spent *renting buses to transport teams to and from Dar es Salaam. And in the rainy season, hospital and construction staff have to be transported back and forth from the main road. Heavy rainy season downpours make for muddy roads, difficult or even dangerous to travel in regular cars. A bus, with its higher clearance, would make the trip more easily. Our focus for the Choices in Mission matching funds for the month of October will be to move closer to the goal of acquiring a bus for IHP-TZ.*

If you are on the IHP-TZ mailing list, you will have read the personal testimonies of volunteers who have given of their time and talents at Zinga. One special education teacher has come nine times! Her creative solutions for children with special physical needs have transformed lives. Medical students write of the transformational experience their time at Zinga has been. They note the patience and compassion of Dr. Kitundu, Dr. Bon, and the other staff at the hospital, and the fact that the hospital staff is all Tanzanian.

In 2008, a team from First Lutheran went to Nyakato near Lake Victoria to work with IHP on the hospital Paula and Denny were developing there. Perhaps it is time to plan another trip, maybe in 2020, to allow time to save up for the travels. Is this something you feel called to do? It is truly a life-altering experience. Our team in 2008 included adults and teenagers, and we went during summer vacation. Including First Lutheran In Your Estate Planning

Most people spend more time planning their vacation then they do their estate. One area that is often overlooked is the opportunity to include charitable organizations, like First Lutheran Church, in your plan. There are several methods for transferring assets and money upon death to non-profits. There are also several ways that funds can be left to charitable organizations depending upon the wishes of the donor. The rest of this article will briefly touch on the ways to transfer and provide more information on the designations of the gifts themselves.

The majority of transfers of assets and cash passed to charitable organizations are done as bequests from a will or trust. These are typically for a specific amount of money, or a specific asset. For example I could have a bequest in my will that would leave \$10,000 to First Lutheran Church. All that is needed is typically the address of the charitable organization, and the tax identification number.

Another option for making charitable gifts is through a designation of beneficiary on a retirement plan, life insurance policy, or IRA. This is typically done by indicating the percentage of the account that you wish to go to the charity. So for example if Wally had a \$100,000 IRA he could indicate that he wants 5% to go to his church. If Wally passes away the day after making the election his church would receive the gift of \$5000. If his IRA grows over time the gift could be larger, or if he uses the funds during retirement the gift could be smaller. Many people make their annual gifts to charities using their annual minimum required distribution. By paying this directly to the charity it is never subject to income tax.

A third way assets can be transferred at the time of death is by operation of law called the transfer on death rule. It is often referred to as a TOD designation. This type of transfer can be used on a bank account, or a securities account with a broker. The most common use is with a bank account. The language on the transfer simply states that upon death the assets are to be transferred to the individual or charity named. These assets pass without being a part of the individuals estate, although the value could still be subject to inheritance and Federal estate tax.

The detail that is included in a bequest, or designation of beneficiary gift, is more important than most people realize. The specific instructions let the charity know how the funds are to be utilized. The following information is specifically for First Lutheran Church. The normal designation for a gift would typically include one of the following:

1. Building Support Fund -this money is utilized towards the upkeep and maintenance of the Church. The assets themselves can be used towards expenses.

2. Mission Support Fund - this money is utilized towards mission activities as designated by the congregation or the council depending upon the specific amount of the request. Most recently these funds have been used to match giving by congregational members.

3. General Fund - gifts made to the general fund can be utilized for normal expenses, or special projects. A General Fund gift allows the most flexibility in allocating the money to where it is most needed.

4. Building Support Endowment Fund -gifts that go into this fund are used to generate earnings that can then go towards building support expenses. The actual gift itself can never be spent.

5. Mission Support Endowment Fund – gifts that go into this fund are used to generate earnings that can then be used towards mission projects in the future. Again none of the actual gift can be used.


6. General Fund Endowment – Gifts of this type are used to generate earnings that can then be used for normal expenses or special projects. Again none of the gift itself can be spent.

7. Designated Gifts - These are gifts that are specifically designated to go towards one purpose. For example funds that were designated to go towards organ repair and restoration. The down-side of specific gifts like this is that if the project never takes place the funds can never be used.
8. Designated Endowment Gifts – these types of gifts are invested and the earnings off of the original gift are used for a specific purpose. For example someone could leave a designated endowment gift to go towards Sunday School supplies. The actual gift itself could never be spent but the earnings off of the gift could be utilized towards that specific purpose. Again the downside to this type of gift is if the earnings exceed the need they can't be used for other purposes. Another possible problem is if the funds are actually needed to cover expenses they still can't be used because of the endowment restriction.

Every charitable or non-profit organization will have their own funds and needs which will determine designations. If you are comfortable speaking with them about your intentions you may learn about designations which you were unaware of that speak to your interests and you wish to support.

The question often asked is what happens if there is no specific designation, and the check is simply made out to the charity? Most organizations have a policy on how these monies are to be handled. First Lutheran Church has a policy that all gifts received that are not specifically designated will be split between the Building Support fund and Mission Support fund. If you have an undesignated gift to the Church in your estate plan you could also provide a letter to the Church indicating your wishes. This would in sense be a supplement to your gift. While leaving money to the Church for the General Fund does not have the emotional lift of a specific mission or replacement of the organ, it may be the most important gift given the changing times within most churches. With declining membership and reduced giving, having adequate funds for the ministry is critical. Logan and his mother, Michaela, didn't know where to turn.

Since Logan was 5 years old, he had moved in and out of hospitals and residential treatment centers across lowa. For 13 years, Michaela tried to find the right approach to address his behavioral needs. But nothing was working.


